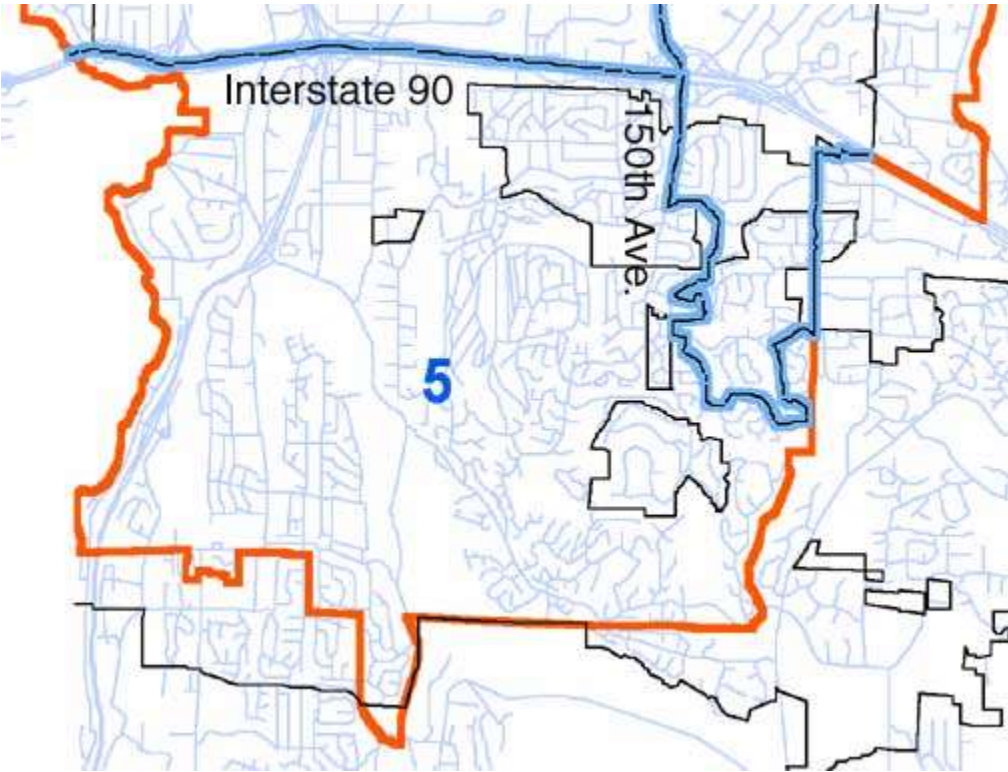


Director District 5



Beginning at the intersection of the easterly shoreline of Lake Washington and the centerline of SR-90; thence east along said centerline of SR-90 to the centerline of 150th Avenue SE; thence south along said centerline of 150th Avenue SE to the centerline of Newport Way; thence northeast, east, southeast, and east along said centerline of Newport Way to the centerline of 152nd Avenue SE; thence south along said centerline of 152nd Avenue SE to the centerline of SE 45th Street; thence southwest along said centerline of SE 45th Street to the centerline of 150th Avenue SE; thence south along said centerline of 150th Avenue SE to the centerline of SE 45th Place; thence southeast along said centerline of SE 45th Place to the centerline of 150th Place SE; thence north and east along said centerline of 150th Place SE to the centerline of 151st Avenue SE; thence south along said centerline of 151st Avenue SE to the centerline of SE 46th Street; thence west along said centerline of SE 46th Street to the centerline of 150th Avenue SE; thence south along said centerline of 150th Avenue SE to the centerline of SE 46th Way; thence east along said centerline of SE 46th Way to the centerline of 150th Place SE; thence southwest along said centerline of 150th Place SE to the centerline of SE 46th Place; thence southeast and south along said centerline of SE 46th Place and 152nd Place SE to the centerline of SE 48th Street; thence east along said centerline of SE 48th Street and SE 48th Drive and the centerlines of 157th Avenue SE and SE 50th Street to the centerline of 159th Place SE; thence north along said centerline of 159th Place SE and the centerline of 158th Avenue SE to the centerline of SE 46th Way; thence northeast along said centerline of SE 46th Way to the east line of the west 1/2 of the Southeast 1/4 of Section 14, Township 24 North, Range 5 East; thence south along said east line and the east line of the Northwest 1/4 of the Northeast 1/4 of Section 23, Township 24 North, Range 5 East to the Southwest corner thereof; thence west along the south line thereof to the northeast corner of the plat of Summit Division No. 2; thence southeast and southwest along the east boundary of said plat and the easterly and southerly boundary of the plat of Summit Division No. 4 to the centerline of 155th Avenue SE; thence southeast along said

centerline of 155th Avenue SE and its projection to the south line of Section 23, Township 24 North, Range 5 East; thence west along said south line of Section 23 and the south line of Sections 22 and 21, Township 24 North, Range 5 East, to the centerline of Coal Creek Parkway; thence south along said centerline of Coal Creek Parkway to the centerline of SE 69th Street; thence northwest along said centerline of SE 69th Street to the west line of the east 1/2 of the Northeast 1/4 of Section 28, Township 24 North, Range 5 East; thence north along said west line to the north line of said Section 28; thence west along said north line to the Southwest corner of the Southeast 1/4 of Section 21, Township 24 North, Range 5 East; thence north along the west line thereof to the Northeast corner of the Southeast 1/4 of the Southwest 1/4 of said Section 21; thence west along the north line thereof to the east line of the plat of Densmore; thence south along said east line to the southeast corner of said plat; thence west along the south line thereof to the centerline of 116th Avenue SE; thence west along the south line of the plat of Bev Brooks Estates to the southwest corner thereof; thence north along the west line thereof to the north line of the south 1/2 of the South 1/2 of Section 20, Township 24 North, Range 5 East; thence west along said north line to the shoreline of Lake Washington; thence northerly along said shoreline to the point of beginning; except Lots 1 thru 8 and Tract A of the plat of Densmore and the southerly half of SE 61st Place and the westerly portion of 118th Avenue SE lying within the Northwest 1/4 of the Southwest 1/4 of the Southwest 1/4 of Section 21, Township 24 North, Range 5 East, all in King County, Washington.
